1. As of August 11, 2008, the Education Department will no longer be adding the last four digits to the course approval numbers. Please discontinue using the last four digits from your course approval numbers.
2. Course completion lists will be sent back if there are any blanks, modifications, incorrect information, etc., so please make sure they are correct and properly filled out.
3. New Education Department database is going online soon. If you want to add a course description for your certified courses, they will be displayed on the website. Please submit your course descriptions for review by the Education Council. The descriptions cannot be more than 200 characters in length. If we do not receive a course description, it will be left blank.
4. Revised Module 1 & 2 are finally completed, so please discontinue use of older versions. If you are a prelicense provider who offers the sales prelicense courses (Mod 1 & 2), please email Jesama at Jesama.Rosensweig@irec.idaho.gov to let her know that you will need the updated versions as well as the revised exams.
