Credit-You must attend all of day 1 and the first half of day 2 to obtain IDW credit for Instructor certification. You will get continuing education credit for attending the 2009 CORE and can be certified to teach it if you pass the final exam. It is optional to attend the BCOO portion of day 2. You can obtain CE credit and/or be certified to teach BCOO if you attend the course and pass the final exam. If you would like to attend only the second day for continuing education credit, you can attend either CORE for \$50, BCOO for \$50 or both for \$90.

***Current certified instructors who wish to become certified to teach either the Commission CORE or BCOO course MUST complete the course and pass the exam. 100% attendance is mandatory for Instructor certification credit or CE credit. It is required to attend IDW or its equivalent at least once during your 2-year instructor certification period.**

Refund Policy-If written notification of registration cancellation is received in the office of Commission at least five working days before the course commencement date, the registration fee, less cost of materials received, may be refunded. NO refund will be made due to non-attendance. In the unlikely event any course is cancelled due to insufficient interest, a full refund will be made to all registrants.
